Estate, Gift, and Generation-Skipping Transfer Taxes

A guarantor is someone who agrees to repay the debt of a company or person if they default. If the company goes into liquidation or the person enters a personal insolvency procedure, e.g. bankruptcy, the guarantor will have to repay the creditor.

For a company in liquidation that has receipts, the liquidator will have to file a Declaration of Receipts and Payments (With Receipts) (1.2MB) with IRAS on a yearly basis. This should be filed with IRAS within one month of end of the period for which the declaration is made.
